Internationally educated engineers and geoscientists must meet this regulatory body's requirements to become licensed. One of the requirements is to successfully pass the National Professional Practice Exam (NPPE), which is a two-hour, 100 multiple choice question examination on law, ethics and professionalism.

95% of the participants who completed the study group in July at Directions successfully passed the NPPE. With them, the total adds to over 238 examinees who

New Fundamentals of Engineering Study Group

This fall Directions for Immigrants will be offering a Fundamentals of Engineering (FE) study group to help internationally educated engineers prepare for the accreditation exam that may be required as part of the accreditation process with APEGA. A pilot group ran from January to April and the upcoming group will start in November. According to Carlos Batista, licensed engineer and facilitator of the group, the participants will:

- Receive support, general guidelines and recommendations for success in FE Exam
- Measure their performance through quizzes and a mock exam
- Review and clarify fundamental concepts
- Share strategies to solve engineering problems

24 International Medical Graduates successfully passed licensing exam




The National Assessment Collaboration Objective Structured Clinical Examination (NAC OSCE) is required as part of the licensing process that international medical graduates (IMGs) have to pursue in Alberta prior to competing for residency. It consists of a series of stations simulating medical situations that involve interactions with standardized (simulated) patients.

24 IMGs who completed the study group at Directions for Immigrants successfully passed the exam, which represents a success rate of 100% for this group.

This summer Directions for Immigrants again ran, as part of the study group, a practice clinical exam (OSCE) at the University of Calgary's Medical Skills Centre. The purpose was to help clients prepare for the NAC OSCE. The practice exam allows participants to understand the style, format and expectations of the real exam, according to Cayti Beyer, career coach at Directions. The practice OSCE was a "fantastic opportunity" for Simon, one of the participants. "No other element helped me prepare more for the reality of this exam than this study group," he said.

For the successful candidates passing the NAC OSCE "the next step is to take the Multiple Mini Interview assessment in November," explains Cayti. Congratulations to all our clients! \Box
